Thank you for your interest in our scholarship program for the 2017-2018 school year. Eligibility for the Delegate Mary Beth Carozza Legislative Scholarship is as follows:

- Be a resident of Legislative District 38C
- Attend a Maryland college, university or trade school (or have a Maryland Higher Education Commission approved unique major)
- Have a cumulative grade point average of **3.0 or higher**

You must return the following items to my office no later than **Saturday, April 15, 2017**:

- Completed application form (including the required essay)
- An **official sealed** copy of your transcript
- A copy of your SAT/ACT scores (**high school seniors only**)
- MHEC requires you to file your FAFSA – please send your FAFSA **summary sheet**. Please **do not** send your entire FAFSA.

If you do not include all of the above items, my office will be unable to process your application. Please note that priority will be given to first-time applicants. Those who have received a Legislative Scholarship in past may apply, but priority will be given to first-time applicants.

You will be notified when all selections have been made, usually before the end of May. Remember that this scholarship **does not automatically renew**, and you will need to re-apply next year.
